**RECEIVER’S 1ST SCHEDULE OF PAYMENTS
TO BE MADE PURSUANT TO THE INTERIM PLAN**

Receiver Ralph S. Janvey (the “Receiver”) hereby files this 1st Schedule of Payments to be Made Pursuant to the Interim Plan (the “1st Schedule”), respectfully stating as follows:

On May 30, 2013, the Court granted the Receiver’s Motion for Approval of Interim Distribution Plan (the “Interim Plan”). [*See* Doc. 1877.] The Court’s Order approving the Interim Plan instructed the Receiver as follows:

Payments under the Interim Plan shall be made on a rolling basis as certifications in response to Certification Notices are received and processed. Prior to making a group of payments pursuant to the Interim Plan, the Receiver shall file a schedule of the payments to be made. Each such schedule shall be filed at least ten (10) days prior to the subject payments being made. The schedules shall include claim ID numbers and the amount of the associated payments but shall not contain information from which the individual Investor CD Claimants can be identified.

[*Id.* at 8.]

The Receiver is filing the 1st Schedule (attached hereto as Exhibit 1) in accordance with the above instructions and expects to begin the process of sending the payments

listed therein once the schedule has been on file with the Court for ten (10) days. The 1st Schedule shows that the Receiver intends to make payments totaling \$1,076,175.08 to the claimants who submitted the referenced claim numbers. This 1st Schedule will be followed by others, each of which will be submitted by the Receiver on a rolling basis as additional responses to Certification Notices are received and processed.
